THE PURCHASING POWER PARITIES AND PRICE LEVEL INDICES IN DECEMBER 1989

The update of the price level index for December shows that price level differences between the EC countries remain very high. By taking Belgium as reference, the price level indices for December 1989 and December 1988 are as follows:

The above figures show also that price level relationships did not change significantly compared with a year ago for all the countries, except the United-Kingdom and Japan where substantial falls of the price level indices can be observed, mainly caused by the depreciation of the currencies of these two countries vis-à-vis the ECU (-13%, -15% resp.) (see Table B, page 5).

N.B.: The calculation method is explained in the methodological note on page 6.



N.B.: Table A should be read horizontally. The following example should make the meaning clearer:

For the same basket of goods and services in private consumption, it would be necessary to spend 100 BFR in Belgium, 5.35 DM in Germany, 16.97 FF in France and 244 ESC in Portugal. By comparison, the exchange rates in the same period were 100 BFR = 4.76 DM, 100 BFR = 16.25 FF, 100 BFR = 417 ESC.

For the same basket of goods and services for private consumption which would require expenditure of 1000 BFR in Belgium, it would be necessary to spend the exchange-rate equivalent of 1124 BFR in Germany, of 1044 BFR in France and of 584 BFR in Portugal, etc..

METHODOLOGICAL NOTE

The purchasing power parities for final household consumption for the base year 1985 are calculated on the basis of extensive price surveys as described in "Comparison in real values of the aggregates of ESA". The specific parities for household consumption are updated by means of the national consumer price index for each of the countries which are regularly published in this bulletin. For each pair of countries the extrapolated parity is obtained by multiplying the 1985 parity by the relative price index.

In the first table (A) the parities are presented in a square matrix in which each country can be compared with all the others. In effect each column gives the parities of every country with respect to a reference country.

The parities obtained in this way have been related to the official exchange rates; the ratio of purchasing power parities to exchange rates is called the price level index. These figures, also presented in a square matrix, are given in the second table (B). Each line of this table shows the difference between the parity and the exchange rate of the base country compared to the other countries. For instance on the first line where Belgium is the base country (= 100), the index for Denmark is 137.3, for France 104.4 and for Portugal 58.4.

In other words: for the same basket of goods and services for private consumption as would require an expenditure of 1000 BFR in Belgium, it would be necessary to spend the exchange rate equivalent of 1373 BFR in Denmark, 1044 BFR in France and 584 BFR in Portugal.

Purchasing power parities are mainly used for short term analysis of household consumption.

EUROSTAT also carries out an annual estimate of purchasing power parities of gross domestic product (see National Accounts - Aggregates), they are generally used for volume comparisons by eliminating the difference of general price level between countries.

The purchasing power parities for the United States, Japan, Canada and Austria are based on studies made by the OECD for the year 1985.
