# NEW SECRETARY-GENERAL OF THE OECD TAKES OFFICE

Mr. Emile van Lennep, Secretary-General of the OECD, took up his duties in Paris today, following his participation in the IMF and the World Bank meetings held in Washington last week.

Mr. van Lennep\* was elected last February for a five-year term by the OECD Ministerial Council. Prior to this appointment he was Treasurer-General of the Netherlands. He succeeds Mr. Thorkil Kristensen of Denmark, Secretary-General since the OECD was established in September 1961.

Among his earlier international assignments, Mr. van Lennep was Chairman of the Monetary Committee of the EEC and Chairman of the OECD Economic Policy Committee's Working Party No. 3, which deals with balance of payments questions.

As Secretary-General, he presides over the meetings of the OECD Council, composed of Heads of Delegation from the Organisation's twenty-two Member countries. He is also the official representative of the Organisation in its relations with both Member and non-Member countries and with other international organisations.
