#### **EDITORIAL**

This is the first issue of the European Community Studies Association (ECSA) Newsletter. It will be published twice a year, in the spring and fall. Although the idea of the Newsletter predates the founding of ECSA, it represents part of the same scholarly initiative. This initiative goes back to May 1984 when a small group of scholars interested in the EC met for a one-day conference organized by Columbia University's Institute on Western Europe. At the conclusion of the conference, it was noted that support for and study of the EC was declining in North America and the suggestion was made and unanimously endorsed that every effort should be made to create an on-going forum for those interested in the EC.

In October 1985, a second and larger meeting was held in Washington, D.C. and in March 1987, a group of scholars met with officials of the Delegation of the Commission of the EC, also in Washington, and discussed ways of strengthening North American academic activities relating to the EC (including the idea of a newsletter). Subsequently, 25 scholars came together in Washington in October 1987 for the third European Community seminar/workshop sponsored by Columbia University's Institute on Western Europe and the University of South Carolina, with the support of the Delegation of the EC. At a special evening meeting, the newsletter project was unanimously approved and it was also decided to appoint a committee to investigate the possibilities of forming our own European Community Studies Association. This committee met on March 12, 1988 and worked out the principal details concerning structure, membership, goals, and activities of the Association and drafted a provisional Constitution for it. The members of the committee are: Desmond

Dinan (George Mason), Roy H. Ginsberg (Skidmore), Leon Hurwitz (Cleveland State), Pierre-Henri Laurent (Tufts), Donald J. Puchala (South Carolina), and Glenda G. Rosenthal (Columbia).

The draft Constitution, reproduced on page 2, provides for the election of a five-person Executive Committee by the membership by mail ballot before the Association's Meeting in May 1989. Until that time, the interm committee will be responsible for the affairs of the Association and urges all those interested to join ECSA. Membership application and a mail ballot for the vote on the Constitution are found at the end of the Newsletter. The fall 1988 Newsletter will announce procedures for nominations by mail to serve on the Executive Committee for a two-year term. The May 1989 Association Meeting will also be the occasion of an academic conference with a program of panels and speakers. All those interested in participating in any capacity in the academic conference should contact any member of the committee. The fall 1988 Newsletter will provide information for submission of panel and paper proposals.

The Co-Editors of the Newsletter welcome submission of any news items for the Fall 1988 issue. Send material pertaining to Transatlantic News, Teaching News, and Publications-Research to Roy H. Ginsberg; material on Conferences-Workshops, Organizations-Institutes, and Fellowships-Awards to Glenda G. Rosenthal; and mailing lists-membership dues to Leon Hurwitz. ECSA's objectives and functions are set out in the Constitution. The committee welcomes any ideas for ECSA as it begins its first year. Now that the Association has been formed, all those involved in it look forward to its lively and active development.

# CONSTITUTION OF THE EUROPEAN COMMUNITY STUDIES ASSOCIATION

### **PREAMBLE**

To foster a critical understanding of the Member-States, historical development, institutions, processes, policies, programs, issues, and problems of the European Community (EC), The European Community Studies Association (The Association) is hereby constituted. The Association exists to develop a community of persons in North America interested in the EC and to raise the level of knowledge about the EC. The Association welcomes members from all academic disciplines, the business sector, and the public sector.

### ARTICLE I. OBJECTIVES OF THE ASSOCIATION

The Association shall promote the study and public awareness of the EC in the following ways: facilitating research projects and other collaborative works among the Association members in order to increase the published literature on the EC; encouraging links between The Association and European counterpart associations and individual Europeans for the purpose of transatlantic cooperation; publishing a newsletter; holding conferences and workshops; organizing panels on the EC at conferences and workshops sponsored by other organizations; seeking and disbursing funds to support The Association's activities; drawing upon the membership to speak publicly on EC issues; and undertaking other programs, activities, and projects deemed appropriate.

### **ARTICLE II. MEMBERSHIP**

Membership in the Association shall be open to all persons and institutions who have paid annual dues. Annual dues shall be established by the Executive Committee.

### ARTICLE III. FINANCES

The Association shall collect and expend monies derived from membership dues and other sources. The Association shall seek and disburse funds by itself and in cooperation with other organizations.

### ARTICLE IV. ORGANIZATIONAL STRUCTURE

The organs of The Association shall be an Executive Committee, an Advisory Council, an Editorial Board, and The Association Meeting. The officers of The Association shall be a Chairperson and a Secretary-Treasurer.

#### Section 1. Executive Committee

The five-person Executive Committee shall be elected by the membership and will serve a two-year term. The term of office is renewable but no member of the Executive Committee may serve more than two consecutive terms. The Executive Committee shall elect from its members the Chairperson and the Secretary-Treasurer. The Executive Committee shall be confirmed in office no later than May 31, 1989 at The Association Meeting after a mail poll of the membership.

### Section 2. Advisory Council

The Advisory Council shall consist of distinguished individuals interested in the EC. Its members shall be invited to serve by the Executive Committee.

### Section 3. Editorial Board

The Editorial Board shall be appointed by the Executive Committee and shall consist of no more than five members including the Editors.

#### Section 4. The Meeting

The Meeting shall be the plenary organ of The Association and shall be held no less than once every two years.

#### **ARTICLE V. FUNCTIONS**

The Executive Committee shall be responsible for achieving the objectives of The Association as contained in Article I. It shall appoint the Advisory Council, the Editorial Board and its Editor, a Nominating Committee, and all other committees it deems appropriate.

The Advisory Council shall assist the Executive Committee in achieving the objectives of the Association.

The Editorial Board shall compile, produce, and distribute all Association publications.

The Meeting shall affirm the election of The Association's officers and offer recommendations concerning The Association's activities.

The Chairperson shall conduct all meetings of the Executive Committee and The Association, shall be an <u>exofficio</u> member of the Advisory Council and shall submit regular reports on The Association's activities to the membership.

The Secretary-Treasurer shall receive and disburse funds to support The Association's activities and shall submit regular reports to The Association.

#### ARTICLE VI. VOTING PROCEDURES

All decisions shall be by simple majority vote.

#### ARTICLE VII. AMENDMENTS

The Executive Committee shall receive proposals for amendments from members. Amendments shall be ratified by The Association membership.

# EUROPEAN UNITY IN CONTEXT; 'MAKING THE NEW EUROPE?': THE PROBLEM OF EUROPEAN UNITY AND THE WORLD WAR

This international conference is being organized by the Department of European and Modern Dutch Studies of the University of Hull (UK) in late September 1988 with the support of the Leverhulme Trust. Papers will be given within the following broad areas:

I. The European Impact of National Socialism and Fascism: International Law-Geopolitics and New Territorial Boundaries (defense and disarmament; states and national autonomy; neutrals, neutralism and the orbit of the powers; central Europe between East and West; Europe as a imperial power; Europe without the Anglo-Saxons; regions and regional identity) and Economic Perspectives (a new order; the restructuring of European business; new patterns of trade; autarky, capitalism and multinationals; towards an agricultural policy).

II. The New Unifiers: Shaping a New Politics (collaboration and the search for a "third way"; resistance, democracy and the birth of a new Europe; Communists and National Fronts; governments-in-exile and the problems of restoration; Christian politics, the churches and a new moral order; youth movements) and Planning for a Reconstructed Europe (critiques of capitalism; corporatism, planning and technocracy; towards welfarism; full employment, freedom and European cooperation; the presence of the super-powers and international realignment; the cultural challenge of the USA). ## THE UNITED STATES AND THE EUROPEAN COMMUNITY: CONVERGENCE OR CONFLICT?

APSA will be hosting for the first time the World Congress of the International Political Science Association. The 14th World Congress, whose theme is the "Globalization of Political Science," will be held in Washington from August 27 to September 1, 1988 (the week before the APSA Annual Meeting). The Research Committee on European Unification (Research Committee 3; Convenor Ghita Ionescu of LSE) is sponsoring at least three panels at the World Congress. The panel chairs will be Ghita Ionescu, Emile Noël and Klaus von Beyme. The Sheraton Washington will be the headquarters for the World Congress. It is within convenient walking distance of the Washington Hilton, headquarters of the APSA Annual Meeting.

### EUROPA INSTITUTE, UNIVERSITY OF AMSTERDAM

An international post-graduate course in European integration, "Analysis of 30 Years of Experience in International Regional Integration: The EEC," will be held in Amsterdam from October 1988 to May 1989. The pur-

pose of the course is to provide postgraduates in law and economics with a thorough understanding of the complex problems of European integration.
