Editorial

This second issue of the European Community Studies Association (ECSA) Newsletter marks several major developments in the life of our new association. There has been a widespread show of interest in ECSA from all over North America and abroad from business, industry and government circles as well as from the academic community. Individual membership has exceeded 100 and several institutions and scholarly associations have expressed a wish to join ECSA. Announcements about ECSA's formation and goals have appeared in many journals and newsletters and will continue to do so. We are aiming for a large and active membership to correspond to what is clearly a surge of interest in the EC as it prepares for 1992 and the establishment of a single market.

The formal steps connected with ECSA's establishment are well under way. For prospective members, the draft of the Constitution is reproduced inside and we urge everyone to fill out the membership form and cast a vote on the Constitution. It is now also time to submit nominations for the election of the first Executive Committee. Details of the nomination procedure appear at the end of this issue. Voting for the Executive Committee will be by mail or in person at ECSA's Conference in May 1989. The Advisory Council of distinguished individuals interested in the EC is in the process of formation and will be announced in the next issue.

In line with ECSA's stated objectives, contacts have already been established with other organizations. This has taken concrete form in two directions. At the annual meeting of the International Studies Association (London, March 29-April 1, 1989), two panels will be listed in the program as ECSA panels. Both panels, one chaired by Roy H. Ginsberg and the other by Glenda G. Rosenthal, will be placed along with a number of others in a grouping under the rubric "European Community-US Relations." In addition, preparations are being made for a joint session at the ISA meeting to be co-sponsored by ECSA, the University Association for Contemporary European Studies (UACES-UK) and the Trans European Policy Studies Association (TEPSA-Brussels).

The ECSA has been most active in preparing for its inaugural conference on May 24-25, 1989. The Interim Executive Committee designated Desmond Dinan (history, George Mason) as Program Chair. The other members of the Program Committee are Sue-Ellen Charlton (political science, Colorado), Hugo Kaufmann (economics, CUNY-Queens), Leon Lindberg (political science, Wisconsin), and Louis Orzack (sociology, Rutgers). George Mason University was selected as the site of the conference for its excellent modern facilities and convenient location in Fairfax (VA) in the Washington, D.C. metropolitan area. The title of the conference is "The European Community in the 1990's: Emerging Concepts and Policies." Calls for papers have been mailed and announcements will soon appear in major publications. Additional details about the conference appear in this issue. We urge all those interested in participating to submit proposals to Desmond Dinan as soon as possible, but no later than December 31, 1988. The Interim Executive Committee and the Program Committee are strongly committed to making this inaugural conference a forum for a wide exchange of ideas on all aspects of the EC. Great encouragement and support at all stages of the preparatory work for the conference have been given by the Delegation of the Commission of the EC (Washington, D.C.) and we gratefully acknowledge its support.

The co-editors of the Newsletter have received a very lively response to the request for materials and information. Our next issue is planned for spring 1989. Ideas and suggestions for news items and sections are most welcome. We hope to include short articles and book reviews in the future. Send materials on Transatlantic News, Teaching News, and Publications-Research to Roy H. Ginsberg; materials on Conferences-Workshops, Organizations-Institutes, and Fellowships-Awards to Glenda G. Rosenthal; and mailing lists-membership dues to Leon Hurwitz. It is clear that the success of ECSA in the space of just six months bears witness to a large body of interest. It is our aim to make the Association responsive in every way to this interest.

CONSTITUTION OF THE EUROPEAN COMMUNITY STUDIES ASSOCIATION

PREAMBLE

To foster a critical understanding of the Member-States, historical development, institutions, processes, policies, programs, issues, and problems of the European Community (EC), The European Community Studies Association (The Association) is hereby constituted. The Association exists to develop a community of persons in North America interested in the EC and to raise the level of knowledge about the EC. The Association welcomes members from all academic disciplines, the business sector and the public sector.

ARTICLE I. OBJECTIVES OF THE ASSOCIATION

The Association shall promote the study and public awareness of the EC in the following ways: facilitating research projects and other collaborative works among the Association members in order to increase the published literature on the EC; encouraging links between The Association and European counterpart associations and individual Europeans for the purpose of transatlantic cooperation; publishing a newsletter; holding conferences and workshops; organizing panels on the EC at conferences and workshops sponsored by other organizations; seeking and disbursing funds to support The Association's activities; drawing upon the membership to speak publicly on EC issues; and undertaking other programs, activities, and projects deemed appropriate.

ARTICLE II. MEMBERSHIP

Membership in the Association shall be open to all persons and institutions who have paid annual dues. Annual dues shall be established by the Executive Committee.

ARTICLE III. FINANCES

The Association shall collect and expend monies derived from membership dues and other sources. The Association shall seek and disburse funds by itself and in cooperation with other organizations.

ARTICLE IV. ORGANIZATIONAL STRUCTURE

The organs of The Association shall be an Executive Committee, an Advisory Council, an Editorial Board, and The Association Meeting. The officers of The Association shall be a Chairperson and a Secretary-Treasurer.

Section 1. Executive Committee

The five-person Executive Committee shall be elected by the membership and will serve a two-year term. The term

of office is renewable but no member of the Executive Committee may serve more than two consecutive terms. The Executive Committee shall elect from its members the Chairperson and the Secretary-Treasurer. The Executive Committee shall be confirmed in office no later than 31 May 1989 at The Association Meeting after a mail poll of the membership.

Section 2. Advisory Council

The Advisory Council shall consist of distinguished individuals interested in the EC. Its members shall be invited to serve by the Executive Committee.

Section 3. Editorial Board

The Editorial Board shall be appointed by the Executive Committee and shall consist of no more than five members including the Editors.

Section 4. The Meeting

The Meeting shall be the plenary organ of The Association and shall be held no less than once every two years.

ARTICLE V. FUNCTIONS

The Executive Committee shall be responsible for achieving the objectives of The Association as contained in Article I. It shall appoint the Advisory Council, the Editorial Board and its Editor, a Nominating Committee, and all other committees it deems appropriate.

The Advisory Council shall assist the Executive Committee in achieving the objectives of the Association.

The Editorial Board shall compile, produce, and distribute all Association publications.

The Meeting shall affirm the election of The Association's officers and offer recommendations concerning The Association's activities.

The Chairperson shall conduct all meetings of the Executive Committee and The Association, shall be an ex officio member of the Advisory Council and shall submit regular reports on The Association's activities to the membership.

The Secretary-Treasurer shall receive and disburse funds to support The Association's activities and shall submit regular reports to The Association.

ARTICLE VI. VOTING PROCEDURES

All decisions shall be by simple majority vote.

ARTICLE VII. AMENDMENTS

The Executive Committee shall receive proposals for amendments from members. Amendments shall be ratified by The Association membership.

The West European Program of the Royal Institute of International Affairs has been under way in its current form since mid-1985 under the leadership of Dr. Helen Wallace.
