Mr. Von Lingen was born in Berlin (Germany) on August 6, 1939. From 1962-68, he studied at the Universities of Bonn and Cologne and graduated with a law degree. From 1969-70, he did postgraduate studies at Osgoode Hall Law School in Toronto (Canada). In 1971-72, he was an intern with the EC Commission in Brussels and then with the German-American Chamber of Commerce in New York.

Mr. Von Lingen joined the European Parliament (EP) in 1973. From 1973-81, he worked on the organisation of visits and conferences and was involved with the information campaign for the first direct elections of the European Parliament. From 1981-89, he was a staff member of the Secretariat of the EP Committee on Youth, Culture, Education, Information and Sport as well as of the Committee on Social Affairs.

From 1989-91, Mr. Von Lingen was an EP exchange official with the Directorate-General for External Relations of the EC Commission. His duties included negotiations of trade and cooperation agreements with most of the Central and Eastern European countries, training schemes for officials from these countries, evaluation of PHAREprojects, and the preparation of expert meetings (G-24, Brussels Network, etc.)

In March 1991, he joined the EP Division for Relations with Central and Eastern European countries, including the republics of the former USSR, where he is an adviser to parliamentary committees and delegations on these countries and is involved with the reception of visitors and delegations from these countries as well as with the working group on the New European architecture after the Maastricht Summit.
