G. MENNEN WILLIAMS SWORN IN AS ASSISTANT SECRETARY FOR AFRICAN AFFAIRS

G. Mennen Williams, former Governor of Michigan, was sworn in today as Assistant Secretary of State for African Affairs. He succeeds Joseph C. Satterthwaite, who is being reassigned.

Mr. Williams was born in Detroit February 23, 1911, the son of Henry P. and Elma Mennen Williams. He attended the Detroit University School and the Salisbury School of Connecticut, and received the A. B. degree from Princeton University in 1933. He was graduated from the University of Michigan Law School in 1936.

After two years as an attorney with the Social Security Board in Washington, Mr. Williams in 1938 became Assistant Attorney General for the State of Michigan. The next year he returned to Washington as executive assistant to the U. S. Attorney General, and in 1940-41 was special assistant to the Attorney General, criminal division.

He served as Deputy Director of the Office of Price Administration for Michigan in 1946-47, and as a member of the Michigan Liquor Control Commission in 1947-48. He was elected Governor of Michigan in November, 1948, and was reelected in 1950, 1952, 1954, 1956, and 1958.

Mr. Williams served in the U. S. Naval Reserve from 1942-46, rising from Lieutenant (jg) to Lieutenant Commander. He was awarded the Legion of Merit with Combat "V", and participated in three Presidential Unit Citations. A member of the Detroit, Michigan and Federal Bar Associations, Mr. Williams has been awarded honorary degrees by Lawrence Institute of Technology, Wilberforce University, Michigan State University, University of Liberia, University of Michigan and Aquinas College.

Mr. Williams' appointment as Assistant Secretary was announced by President-elect Kennedy on December 1, 1960.

Mr. Williams is married to the former Nancy Lace Quirk of Ypsilanti. They have one son and two daughters.
