## Mr. Bernhard ZEPTER becomes Head of the European Commission's Delegation in Tokyo.

The European Commission today decided to transfer Mr. Bernhard ZEPTER, Commission official of German nationality, from the Secretariat General to the post as Head of the Tokyo Delegation in Japan under the Directorate General of External Relations. Mr. Zepter will be working closely with the relevant services in Brussels Headquarters in deepening political, economic, social and commercial relations with the host country.

Mr. Zepter, 57, studied law and economics and graduated from the University of Freiburg in 1973. He has a long track record in various diplomatic and international relations positions, including postings as First Secretary of the German Permanent Mission to NATO and Deputy Head of the German Delegation to the Multilateral Trade Negotiations (Uruguay Round), Geneva.

Mr. Zepter joined the European Commission in September 1990 as diplomatic advisor and then Deputy Head of the cabinet of President Jacques Delors. After going back to the German Foreign Ministry in 1995 to head the task force on enlargement, he returned to the Commission in 1997 to become Deputy Secretary General. This appointment is part of the series of rotations announced in January 2002.
