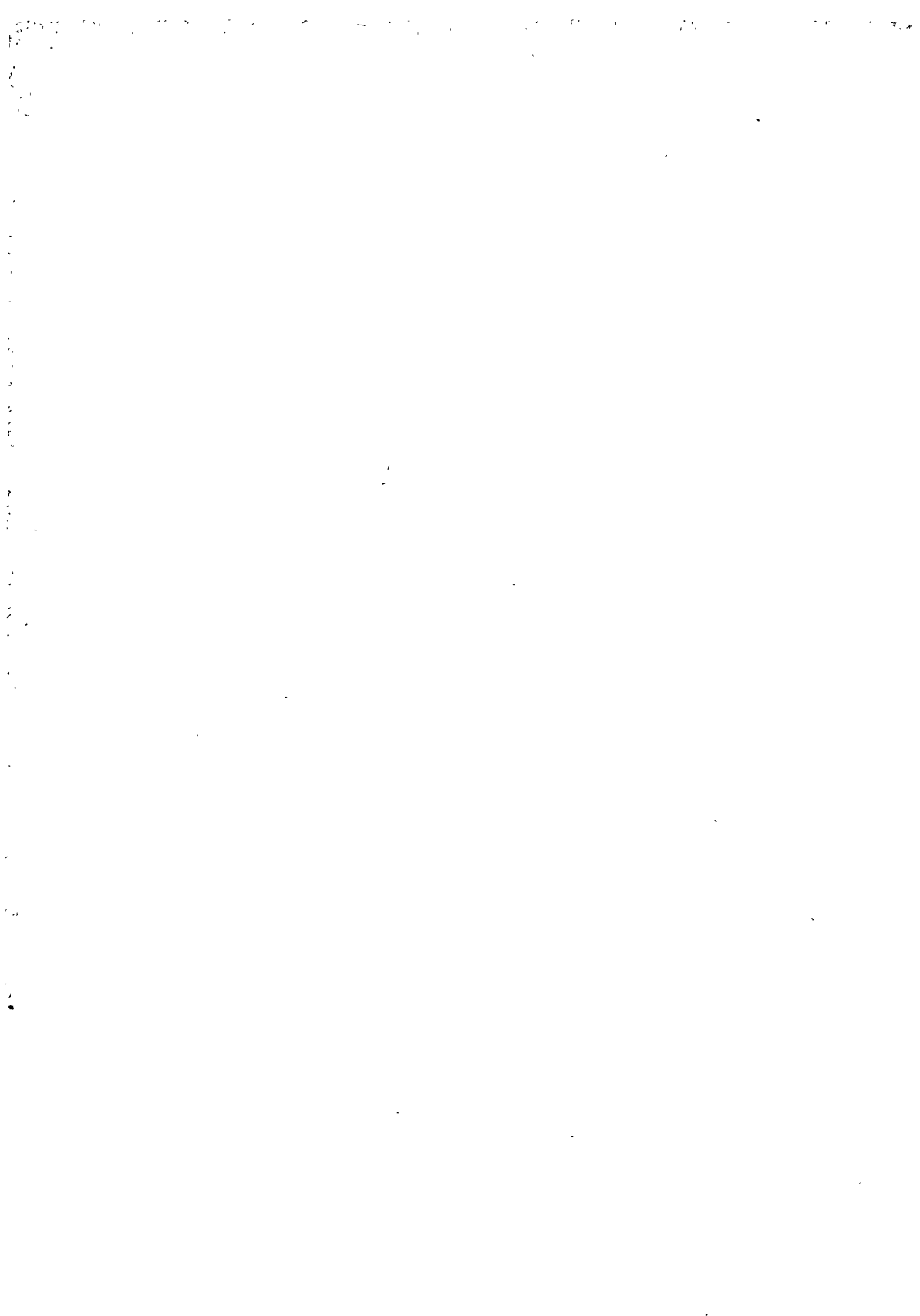

FOREWORD

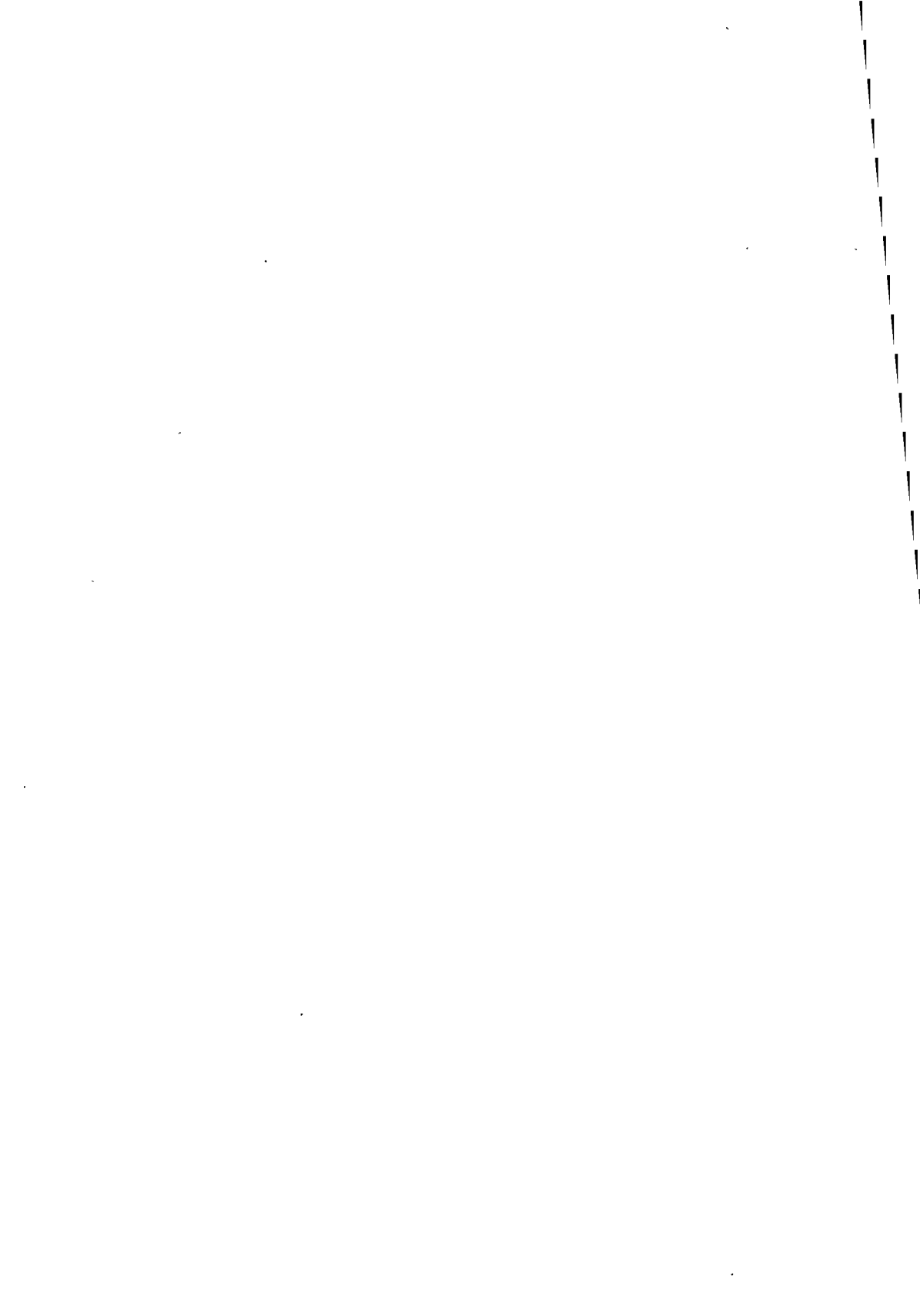
Wherever expedient, subjects which may be seen from different angles are indexed under more than one heading. This applies, for instance, to competition in transport, agricultural products involved in association agreements and the work of GATT Committee II (Agricultural Policy), etc.

Attention is drawn to Supplement No. 2 on the main points covered in market organization regulations and the guidelines for work in the social sector and to Supplement No. 3 on common transport policy following the Council Resolution of 20 October 1966.

Supplement No. 8 deals with the tax harmonization programme and the programme for the harmonization of direct taxes, and Supplement No. 12 provides a full survey of the work done on the approximation of legislation between 1 January 1958 and 31 March 1967.

The chapter on the Institutions (Ch. VI) comprises a chronological list of the meetings of the Community Institutions and Organs, since the subjects dealt with at the meetings are already covered in the relevant chapters.

The cases in the Court of Justice section are referred to in numerical order.
