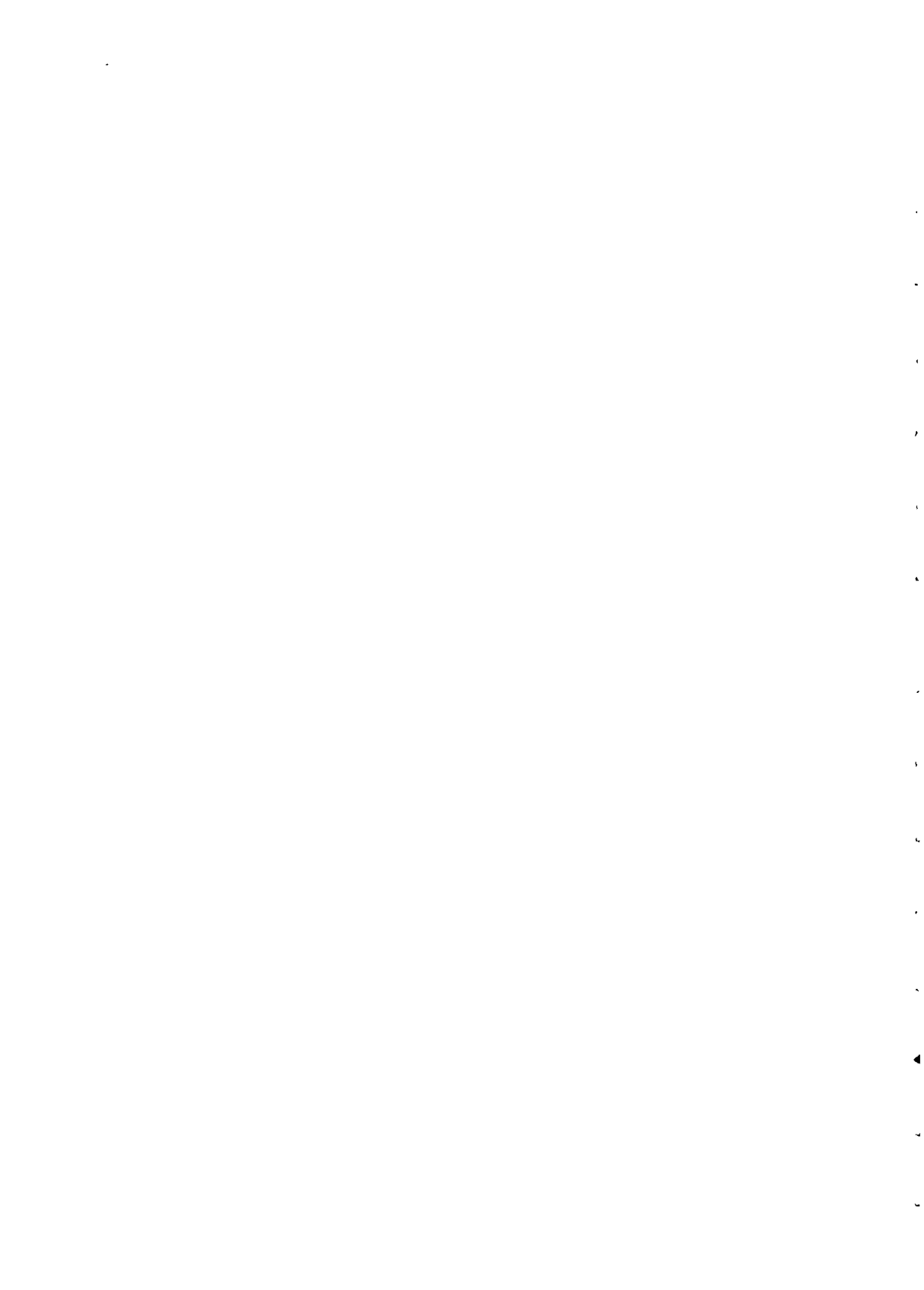

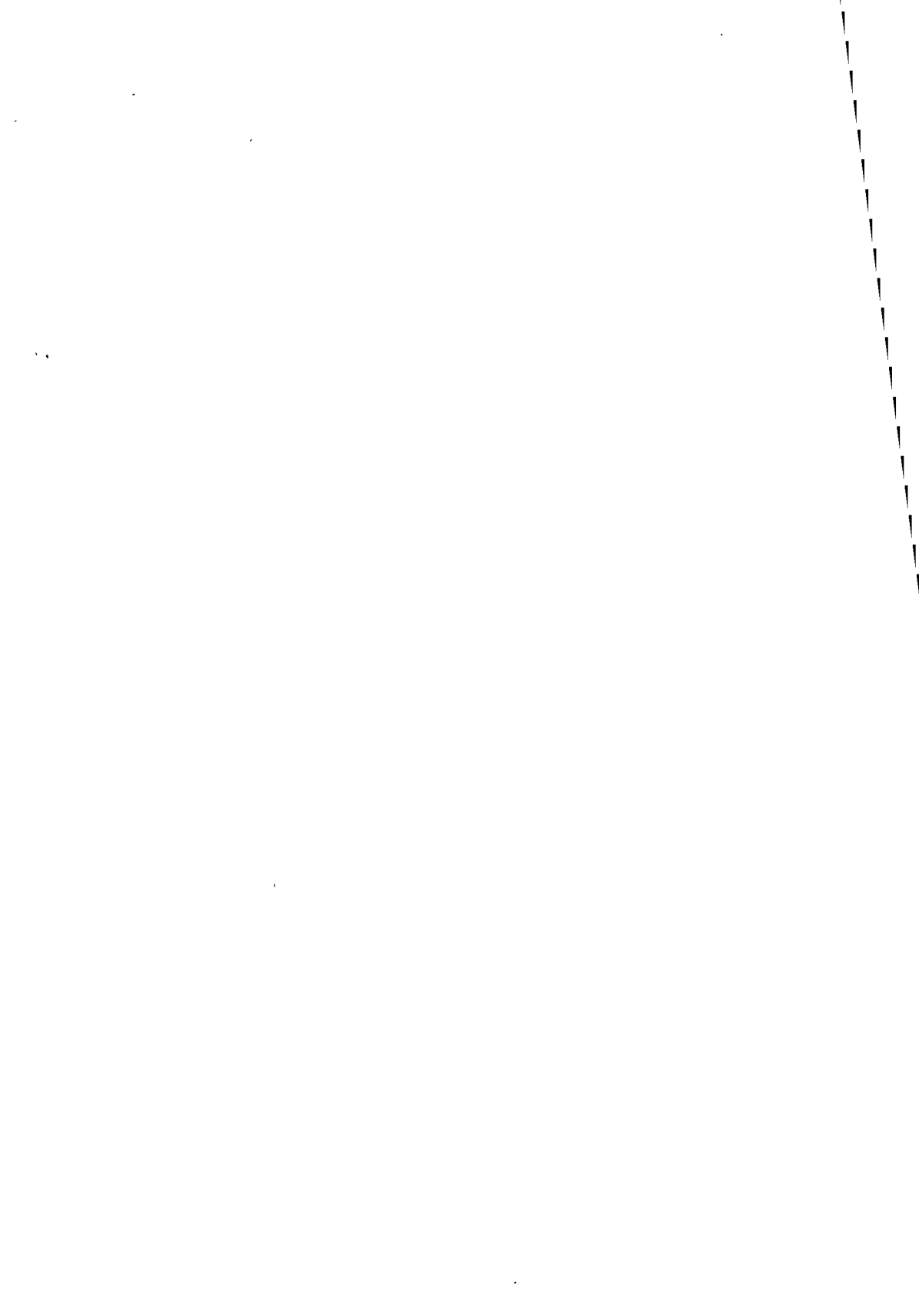

FOREWORD

The Bulletin of the European Economic Community, which has been published since 1958, is now more in demand as reference work for those who, in various capacities, are engaged in studies on the manifold aspects of the implementation of the Rome Treaty and the creation of the Common Market. It is therefore felt that an index to the Bulletin will be of service.

The present index is for the year 1964. The editors have on this occasion made a general classification of subjects, which will be used in the recapitulatory index for 1958 to end of 1963, to be published shortly at the same time as that for 1965. In future an index will be published annually.

The subjects are indexed under headings corresponding with the present plan¹ of the Bulletin (adopted from No. 11/64 onwards); they are numbered as follows:

- I. Internal activities of the Community
- II. External activities of the Community
- III. The Community and the associated States
- IV. Institutional questions
- V. Administrative affairs
- VI. Activities of institutions and organs of the Community (chronological index)
- VII. Addresses and statements
- VIII. Miscellaneous

The references given for the items in the index indicate the number of the Bulletin or Supplement and the chapter, section and page.

There were eleven issues of the Bulletin in 1964, Nos. 9-10 being combined. That year there was a supplement to every issue.

Certain difficulties have arisen from the fact that the present plan of the Bulletin differs from the previous plan and also that various subjects may be treated from different angles and therefore classified in several ways. Wherever necessary for convenient reference these subjects have been placed under two headings.

As regards the proceedings of the institutions and organs of the Community (a chapter on which appears regularly in the Bulletin), Section VI of the index gives only the dates of meetings; the matters treated have been classified either in the Section appropriate to the subject (this is invariably the case for the Council) or under a special heading at the end of each Section (in particular for the European Parliament and the Economic and Social Committee).

The development of the Community over the past nine years, the widening range of subjects dealt with, their interrelation and the diversification of procedures have given rise — and will continue to do so — to certain problems of classification. No doubt use will reveal gaps, and improvements or corrections will be needed in future issues. It is hoped, however, that this first index will be of service to the growing number of readers of the Bulletin.
