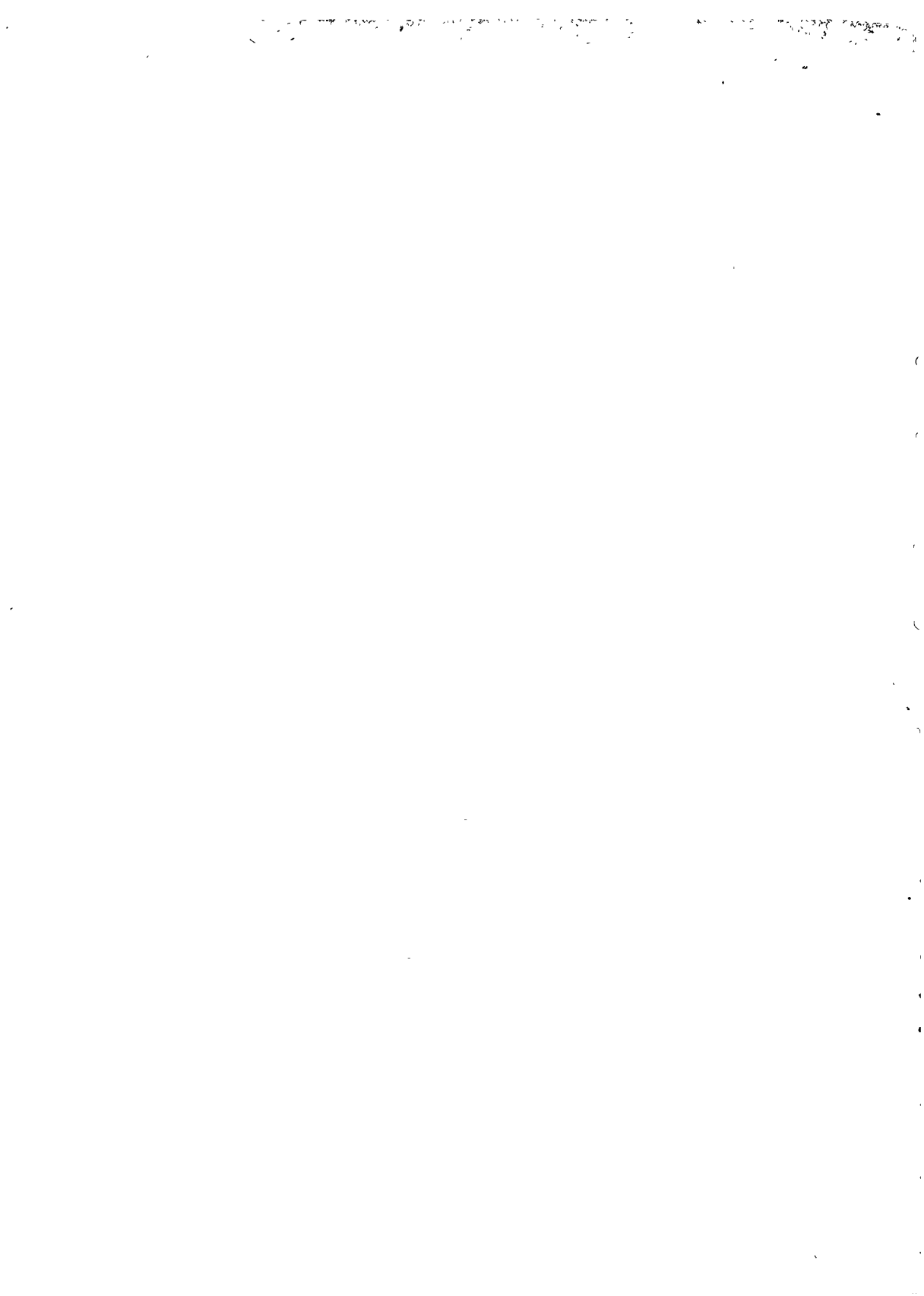

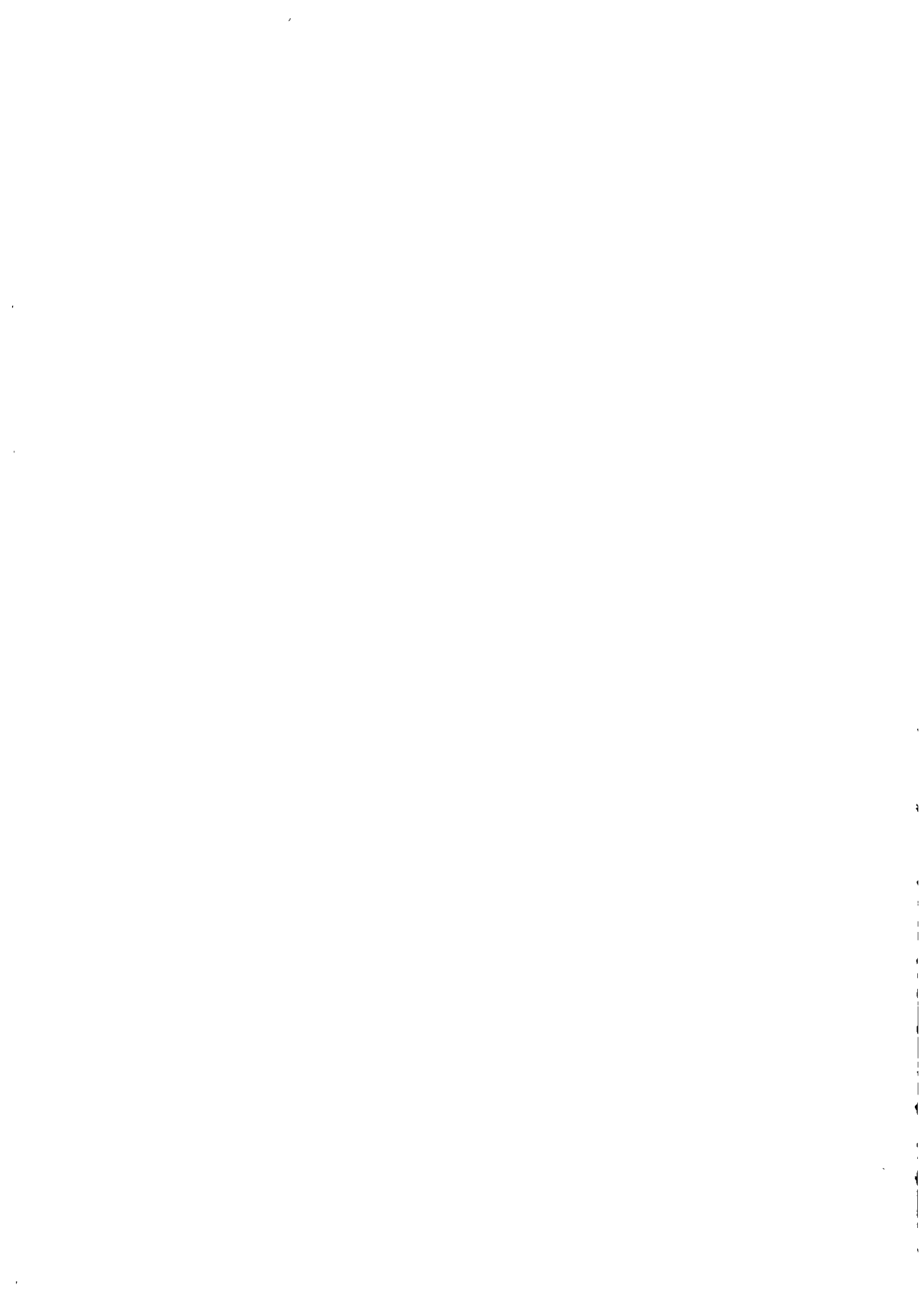

FOREWORD

The subjects are broken down according to the layout for the Bulletin which was adopted from No. 11/1964 onwards, and appear in the index under the following headings:

- I. Internal activities
- II. External activities
- III. The Community and the Associated States
- IV. Institutional and political questions

- VI. Activities of the institutions and organs of the Community

- VIII. Speeches and statements

The references to the text which are placed opposite the various items of the index denote successively: number of bulletin or supplement, chapter, section and page.

The twelve numbers for the year 1965 were published in eleven issues (numbers 9 and 10 comprising a single issue), and numbers 1 to 8 were each accompanied by a supplement.

Whenever it appeared expedient, subjects which may be dealt with from different angles have been indexed under more than one heading (e.g., application of the rules of competition to agriculture has been indexed under both "agriculture" and "competition"). Further outstanding examples are competition in transport, products re-negotiated under Article XXVIII of GATT, agricultural products involved in association agreements, the work of GATT Committee II (Agricultural Policy), etc.

Special attention is drawn to Supplement No. 8-1965, which provides a complete survey of work in the field of harmonization of legislation from 1 January 1958 to 31 March 1965.

Chapter VI of the index simply lists the meetings of the Community institutions and organs in chronological order, as the subjects dealt with at those meetings have been grouped in the chapter on the matter concerned.

In the "Court of Justice" section the cases have been classified in numerical order.
