Introduction

The catalogue of documents, which contains the COM documents of the European Commission, the opinions of the Economic and Social Committee and of the Committee of the Regions, is prepared by the Office for Official Publications of the European Communities for distribution to the public.

The COM and ESC document sare available on paper and microfiche.

The CDR documents are only available on paper, by subscription.

This version of the catalogue takes account only of documents of which English language texts have been prepared. There are parallel catalogues covering documents in each of the 10 other official languages of the European Union.

Presentation

Documents are listed in numerical order within each document type under 17 main headings.

In the classified index, there is one single entry for each document, showing its number, title, date of adoption by the institution concerned, number of pages, catalogue number and finally, for ESC documents, the microfiche reference number. Since 1987,

the COM document numbers have been used as microfiche reference numbers.

Frequency and cumulation

Catalogues of the present type appear monthly. Cumulative annual catalogues are published yearly, containing alphabetical and numerical indexes together with the classified index.

Subscription system

An attractive system of subscriptions is offered for the paper and microfiche versions of the COM documents and the opinions of the ESC covered by this catalogue either individually or in combination.

Another advantageous system of subscriptions combines the COM, CES and CDR documents.
