

Following the Council Decision of 17 March 1981 to increase the number of judges and advocates—general, the Court presented a supplementary estimate for 1981.

In view of the time required for this matter to be considered and the urgency of the situation, the Court has concluded that as an interim measure it must request the non-automatic carryover of 177 600 EUA out of the 184 117 EUA remaining available on 31 December 1980 under Title 2 of the budget. These appropriations will be used in accordance with Chapters 20 and 22 of the supplementary estimate for 1981, as detailed above.

Furthermore, in view of the urgency of this matter, the appropriations carried over, other than those under Article 204 and Items 2310 and 2230, will be simultaneously transferred to the headings where increases are required.

In view of the Commission's powers under Article 21(3) of the Financial Regulation to make transfers from article to article, the budgetary authority is requested to authorize the following transfers from chapter to chapter:
