

#### EXPLANATORY MEMORANDUM

- 1. The purpose of these proposals is to maintain for a further marketing year at their present rates:
  - (a) production refunds on maize groats and meal, broken rice and other starch products used in brewing
  - (b) production refunds on quellmehl used in breadmaking
  - (c) the potato starch premium.
- 2. The Council decided last May (Regulation 1125/78, 1126/78 and 1127/78) to grant production refunds on the products mentioned at (a) and (b) above until the end of the 1978/79 marketing year pending a general decision on the starch production refund system as a whole.
- 3. At the same time, the Council also decided to introduce a premium of 10 ua/t for potato starch for the 1978/79 marketing year which took account of the differing situations in the maize and potato starch industries.
- 4. Since the situations in the potato and maize starch industries have not changed sufficiently to justify an alteration in the premium and since no general decision has been taken on the starch sector as a whole, the Commission is proposing that the premium and the production refunds listed at paragraph 1 a) and b) should be maintained for a further marketing year.

Whereas Article 9 of Council Regulation (EEC) No 1418/76 on the common organisation of the market in rice 3, as last amended by Regulation (EEC) No 4 enables a production refund to be granted for broken rice used by the brewing industry until the end of the 1978/79 marketing year;

Whereas no general decision has yet been taken on the system of production refunds, it is desirable to prolong the possibility of granting production refunds for products intended for the brewing of beer for a further marketing year;

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals 1), as last amended by Regulation (EEC) No 2), and in particular Article 11 (4) thereof,

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice 3, as last amended by

4, and in particular Article 9 (2) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulations (EEC) No of 1979 5) and No of 1979 6 amending respectively Regulation (EEC) No 2727/75 on the common organization of the market in cereals and Regulation (EEC) No 1418/76 on the common organization of the market in rice permit the granting of production refunds for products used for the brewing of beer and in the manufacture of quellmehl used in breadmaking for a further marketing year, it is necessary to extend the period provided for in Council Regulation (EEC) No 2742/75 on production refunds in the cereals and rice sectors 7) as last amended by Regulation (EEC) No /78 8),

Whereas Council Regulation (EEC) No 1127/78 of 30 May 1978 amending Regulation (EEC) No 2742/75 fixed a premium of 10.00 units of account per tonne of potato starch for the duration of the 1978/79 cereals marketing year; whereas no general decision has/been taken on the system of production refunds as a whole; whereas the relative situation of the maize and potato starch industries have not significantly changed it is desirable that the premium should be maintained for a further year,

It shall apply on the 1 August 1979 for products covered by Regulation (EEC) No 2727/75 on 1 September 1979 for products covered by Regulation (EEC) No 1418/76.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

amending Regulation (EEC) No 2727/75 on the common organization of the market in cereals

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament 1),

Having regard to the opinion of the Economic and Social Committee 2),

Whereas Article 11 of Council Regulation (EEC) No 2727/75 on the common organisation in the market in cereals 3, as last amended by Regulation (EEC) No 4) enable production refunds to be granted for maize used for the manufacture of groats and meal used in the brewing industry and maize and common wheat used for the manufacture of quellmehl intended for breadmaking;

Whereas, pending the outcome of a general examination of the system of production refunds in the starch sector, production refunds for products intended for the brewing of beer and for the manufacture of quellmehl for baking were to be granted for the 1978/79 marketing year only;

Whereas a general decision has not yet been taken on the system of production refunds, it is desirable to prolong the possibility of granting refunds on the products in question for a further marketing year;

#### Article 1

Article 11 (1) of Regulation (EEC) No 2727/75 shall be replaced by the following:

- 'l. A production refund may be granted:
  - (a) for maize and common wheat used in the Community for the manufacture of starch;
  - (b) for potato starch;
  - (c) for maize groats and meal used in the Community for the manufacture of glucose by direct hydrolysis;
  - (d) until the end of the marketing year 1979/80, for maize used for the manufacture of maize groats and meal (gritz) used by the brewing industry;
  - (e) until the end of the marketing year 1979/80, for maize and common wheat used in the Community for the manufacture of quellmehl intended for baking.

However, the production refund for/products intended for the brewing of beer may be granted until the end of the marketing year 1979/80

#### Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

It shall apply from 1 August 1979.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
