PETER SCHMIDHUBER, MEMBER OF THE COMMISSION OF THE EUROPEAN  
COMMUNITIES, RESPONSIBLE FOR ECONOMIC AFFAIRS, REGIONAL POLICY  
AND STATISTICAL OFFICE

Mr. Schmidhuber was born in Munich on December 15, 1931. He studied law and economics at the University of Munich and received a B.A. in Economics in 1955. He passed his bar exam in 1960.

Since 1952, as member of the Christian Social Union (the Bavarian branch of the Christian Democratic Party), he has been very active in German politics until he was appointed a Member of the Commission of the European Communities on September 22, 1987.

From 1961-72, Mr. Schmidhuber was employed in the Bavarian State Ministries of Finance (Legal Department), Economics and Transport (tax law and competition law), his last post being the Head of the Competition Section. He practiced law in Munich from 1972 to 1987.

From 1965-69 and from 1972-78, he was a member of the Bundestag, where he sat on the Committees for Economic Affairs (responsible for competition law and issues concerning small businesses), Tax Law Reform and Economic Crime Prevention. He was also a member of the Council of Europe and of the Assembly of the Western European Union.

From 1978 to September 1987, Mr. Schmidhuber was a member of the Bavarian Parliament, Bavarian State Minister for Federal Affairs and Representative of the State of Bavaria to the Federal Government, as well as a member of the Bundesrat (the second chamber of the German legislature). During this period, he was also a member of the North Atlantic Assembly.

Studied law and economics at Munich University.

1955 - graduate in economics.

1956 - first State legal examination.

1960 - second State legal examination.

1961-1972 - active in the Bavarian State Ministry of Finance (legal department) and of Economic Affairs and Transport (tax law, competition law); finally, head of the competition sub-section.

1969-1971 - head of department in an industrial association.

Lawyer in Munich since 1972.

Member of the CSU since 1952.

Various posts held in the party, including member of the Federal Governing Body of the CDU/CSU Association of Small and Medium-Sized Undertakings; member of the CSU "Landesvorstand" (Land Governing Body).

From 1960-1966 honorary Munich city councillor.

From 1965-1969 and from 1972-1978 respectively, member of the Federal German Bundestag.

Member of, inter alia, the Business Committee (competent in matters of competition law and matters concerning small and medium-sized undertakings) and the Tax Law Reform and Anti-Business Discrimination Committees, and of the Council of Europe and the Western European Union Assembly.

From 1978-1987, member of the Bavarian Landtag and Bavarian State Minister for Federal Affairs and Proxy for the Free State of Bavaria to the Federal Government. In this capacity, member of the Bundesrat (Upper House), member of the Bundestag and Bundesrat Mediation Committee and Member of the North Atlantic Assembly.

Member of the Commission of the European Communities since September 1987.

Born December 15, 1931, in Munich. Roman Catholic. Widower, one child.


In 1951, school-leaving examination. Studies in Law and Economics at the University of Munich. In 1955, Bachelor of Economic Science examination. In 1956, first State examination in law; second State examination in law in 1960.

From 1961 to 1972, worked in the Bavarian Ministries of State for Finance (Legal Department), Economics and Transport (Fiscal Law and Competition Law), ultimately becoming head of the subdivision for competition. From 1969 to 1971, acted as head of department in an industrial federation. Lawyer in Munich since 1972.

Member of the Christian Social Union (CSU) since 1952. Has held various party offices, including member of the executive federal board of the Christian Democratic Union (CDU)/CSU Association of the Middle Classes and member of the CSU *Land* executive board. From 1960 to 1966, honorary counselor of the *Land* capital, Munich.

From 1965 to 1969 and from 1972 to 1978, member of the *Bundestag* (lower house of Parliament). Member of, inter alia, the Economic Committee (responsible for competition law and middle-class issues) and of the Fiscal Law Reform Committee and the Economic Criminality Prevention Committee; member of the Council of Europe and of the Western European Union (WEU) Assembly. Since 1978, member of the Bavarian Parliament. Bavarian Minister of State for Federal Affairs and Federal Government representative of the Bavarian Free State since November 9, 1978. Also since 1978, member of the *Bundesrat* (upper house of Parliament), the Mediation Committee of the *Bundestag* and *Bundesrat*, and the North Atlantic Assembly.

Appointed Member of the Commission of the European Communities for the period September 22, 1987, to January 5, 1989.
