Cohesion fund: 1997 outturn

In 1997, the Cohesion Fund committed all of its financial allocation for the year. Compared with previous years, it provided more finance for environmental projects (54.4% of resources) than for projects connected with trans-European transport networks (45.5%).

The breakdown between these two sectors, which started out being more biased towards transport, is approaching the intended equilibrium between the two for the whole 1994-99 period. The split in 1993-97 was 49.1% for environment projects and 50.8% for transport projects.

The emphasis of the Fund's assistance in 1997 was more on managing and monitoring

projects already adopted than on the adoption of new projects. About 40% of its allocation for 1998 and 1999 will be devoted to projects already running, leaving 60% available for new projects.

RECITE II co-operation projects

The European Commission has made an initial selection of 56 projects under the RECITE II programme, which deal with cooperation among regions and cities in the European Union. Final approval of Community funding for the various RECITE projects under Article 10 of the ERDF Regulation will be spread over the months of March to June 1998, after meetings with the project promoters.

Following the Commission's call for tenders launching the RECITE II programme in October 1996, it received 301 proposals and has made a preliminary selection of 56. These projects are distributed among the various co-operation topics proposed as follows:

- 33 projects involving the development of small and medium-sized businesses
- 13 projects involving environmental protection
- 5 projects involving equal opportunities between men and women
- 5 projects involving the development of local potential.

Adoption of three new programmes

The Commission has recently approved Community funding for three new programmes:

Madrid (Spain) Objective 2

This programme is to receive a Community contribution of almost ECU 194 million in 1997-99 and is designed to support the economic and social restructuring of declining industrial areas in the Madrid region. Most of the budget involves the promotion of employment and competitiveness and the internationalisation of economic activities. Other priorities are research, technology and information, environmental protection, the servicing of commercial estates, and local and urban development. The area covered has a population of 1.2 million and a surface area of 500 km², including about a hundred industrial parks and three universities.

Basque Country (Spain) Objective 2

The Objective 2 programme for 1997-99 in the Basque Country is to receive a Community contribution of over ECU 370 million. This programme is designed to meet the same economic and social restructuring priorities as for Madrid, and the major part of resources is also concentrated on employment, competitiveness and the internationalisation of economic activities. The eligible areas in industrial decline have a population of more than 2 million (98% of the regional population) and cover 4 500 km².

Depressed urban area in Syracuse (Italy)

This is a global grant with a Community contribution of ECU 25 million to support productive investment by small businesses (mainly under a state-aid scheme) and services to small businesses in Syracuse (Sicily). This area is faced with the economic and social impact of the decline of major local companies, in particular in the chemicals sector. The intermediary body managing the grant is CO.SVI.S. Spa.
