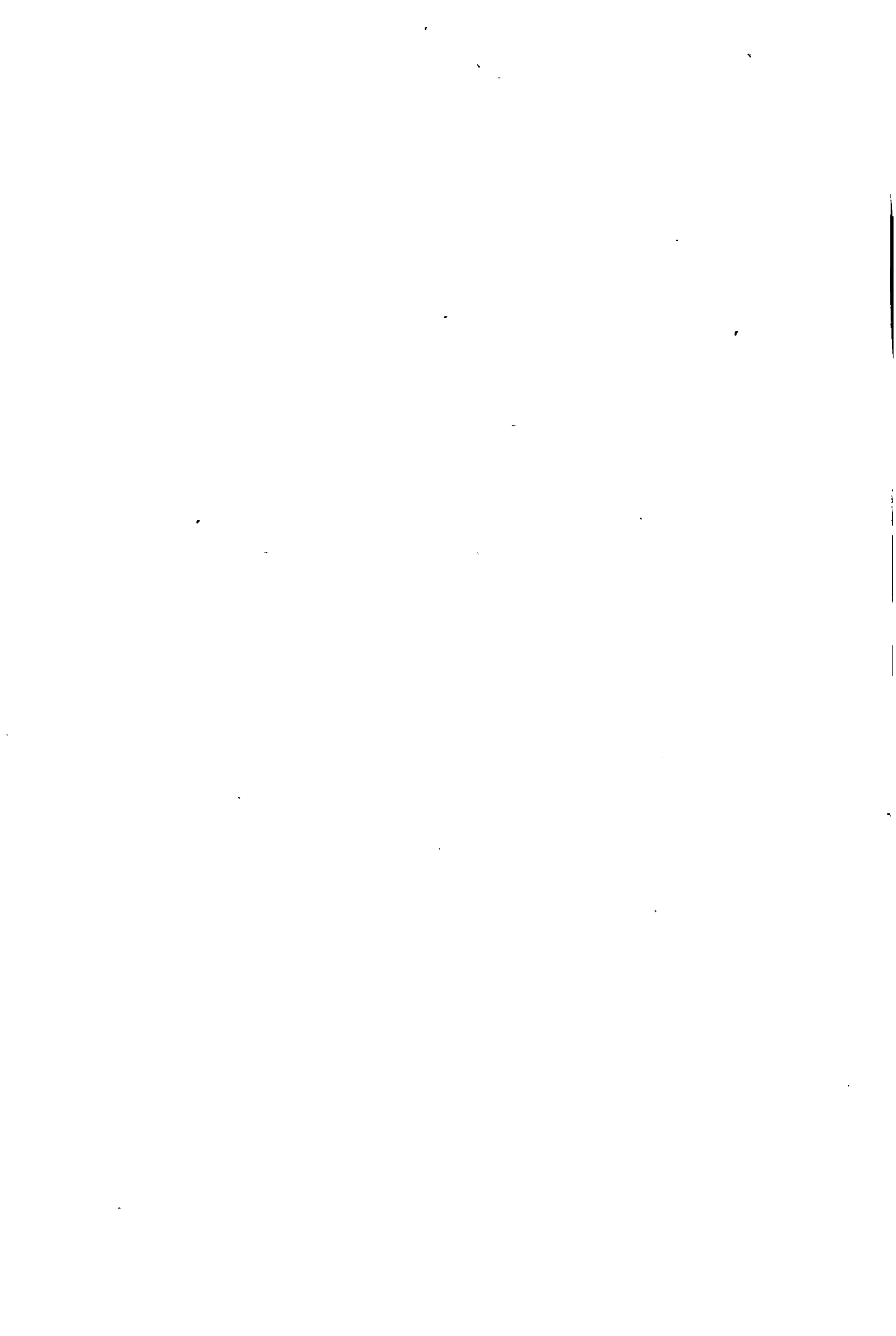

This recapitulatory index has been drawn up to meet the needs of readers of the Bulletin of the European Communities which, as you know, has since 1968 provided an account of the activities of all the institutions of the three Communities — the European Economic Community, the European Coal and Steel Community and the European Atomic Energy Community. The Bulletin is published by the Commission's Secretariat for all those who cannot keep in daily touch with Community work but, for professional reasons or out of personal interest, either require a full survey at intervals or need to keep abreast of a specific aspect. The Bulletin has come to include an impressive number of news items, articles, features and documents. The great mass of material and the complexity of the issues dealt with have made an annual index even more necessary.

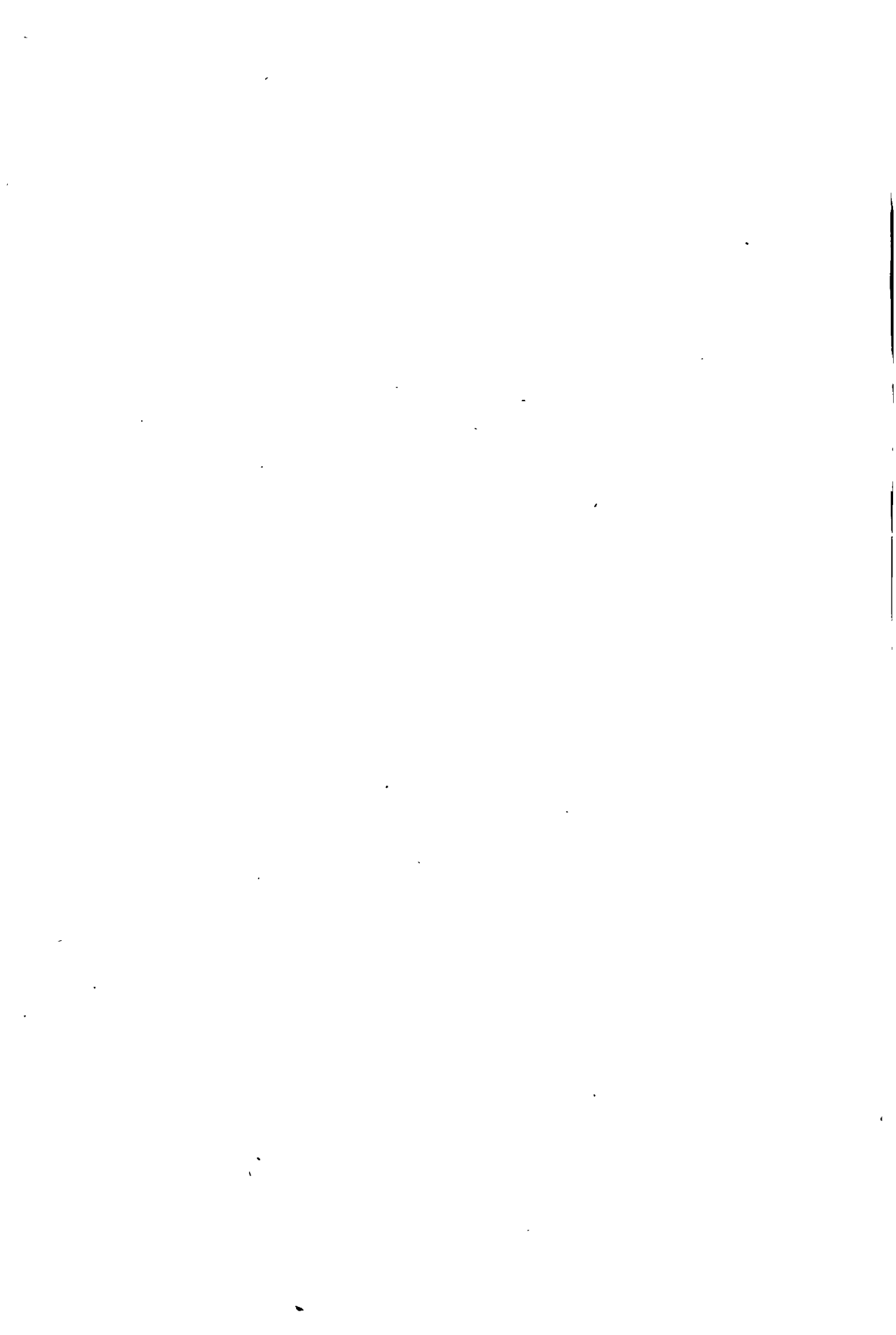
But it had to be decided whether to continue to improve the Bulletin or to bring out a full index as quickly as possible. It was decided, of course, that the Bulletin itself came first. We apologize to readers for the consequences of a decision which, unfortunately, has led to the tardy appearance of the index for the 1969 Bulletin. The disadvantages of the delay have not been overlooked. Steps were taken in 1970 to such good effect that we can look forward to forthcoming indexes being prepared more efficiently and to a steady reduction in the time lag. In the meantime, an "index to introductory chapters and supplements" was published in Bulletin No. 12 for the years 1969 and 1970.

The index to the 1969 Bulletin has a separate section for each of the main Bulletin chapters, namely:

References to the main body of the Bulletin are given on the right-hand side of the index pages. They show firstly the number of the Bulletin or Supplement in which the item appears, and secondly the section or chapter and page.

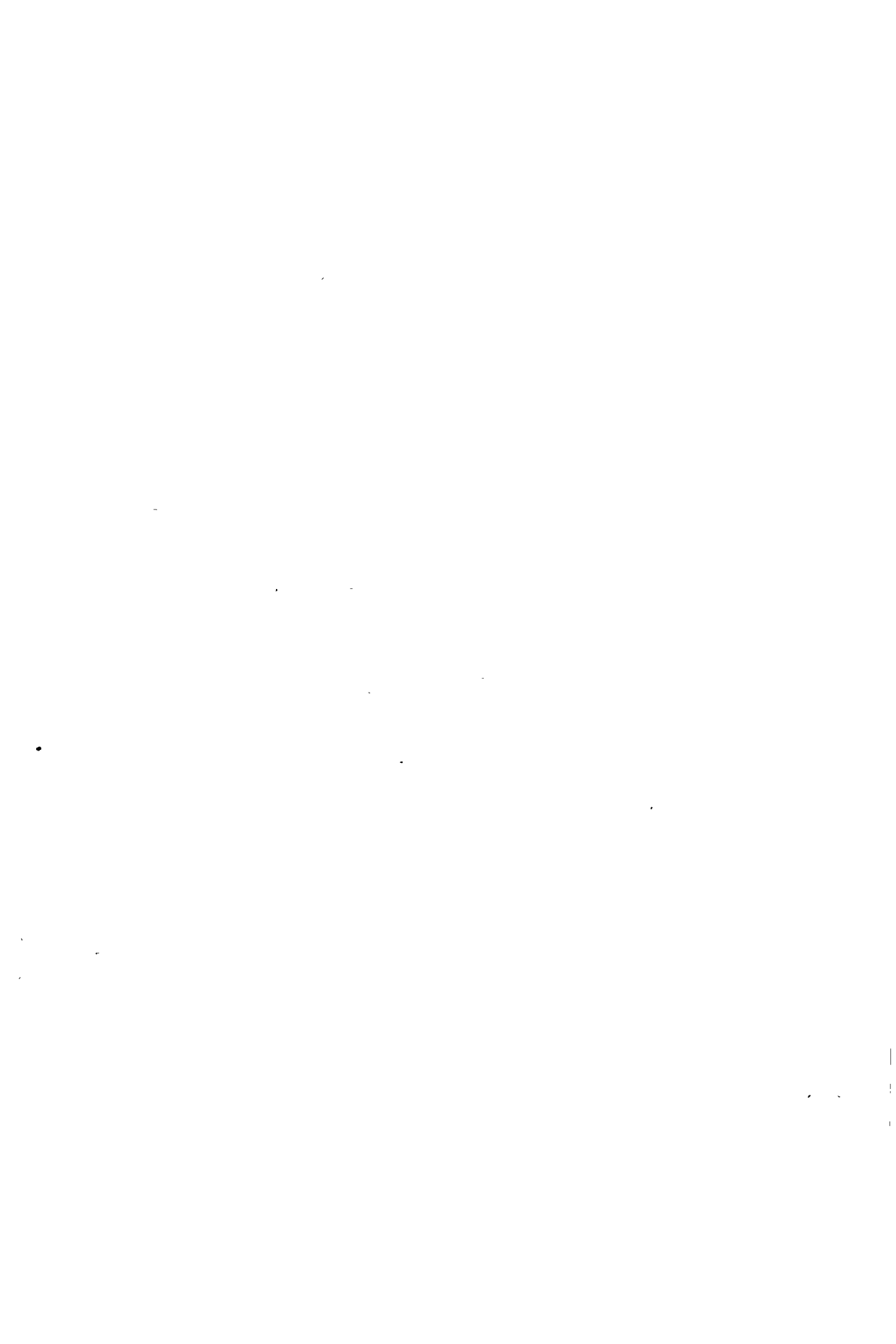

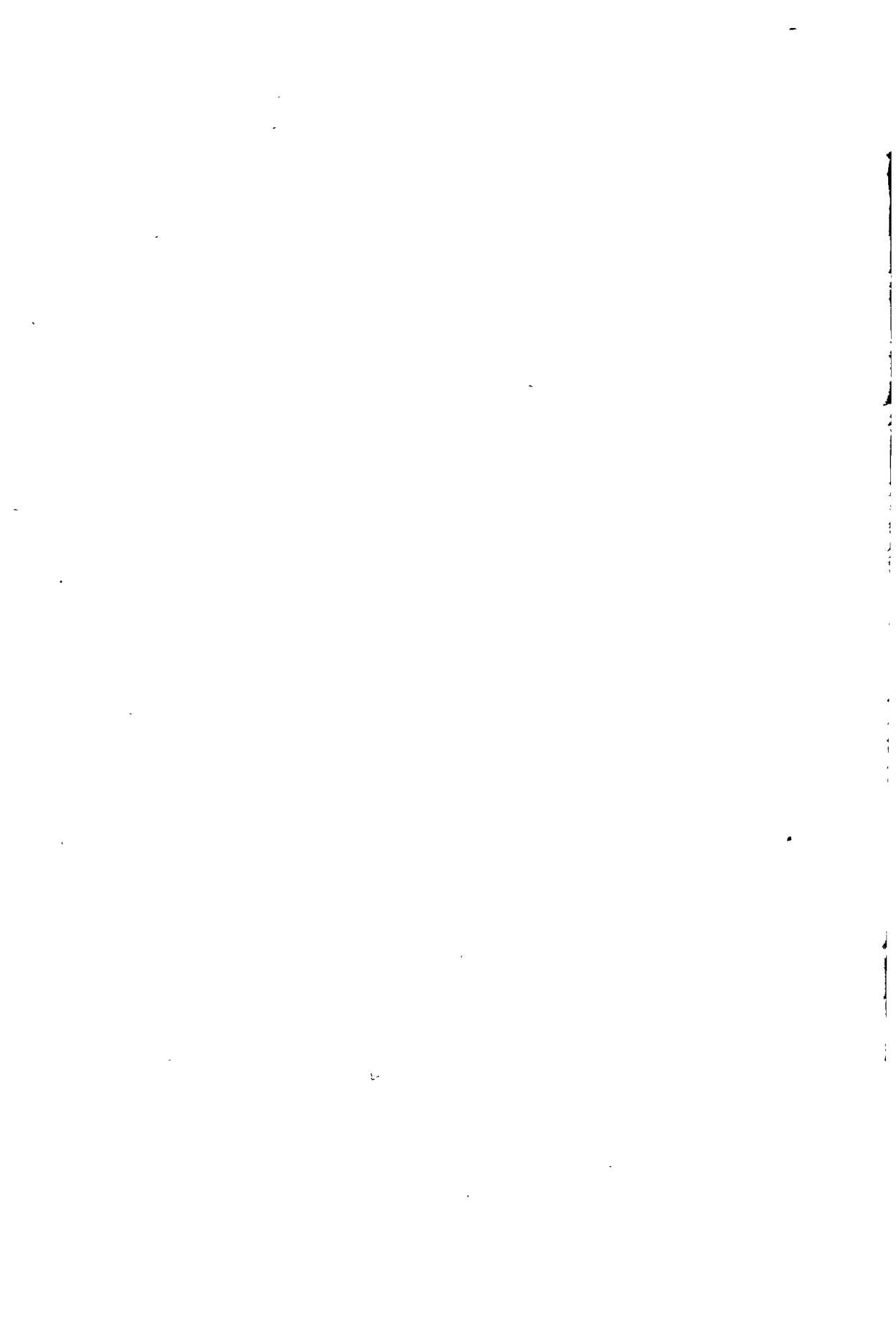
