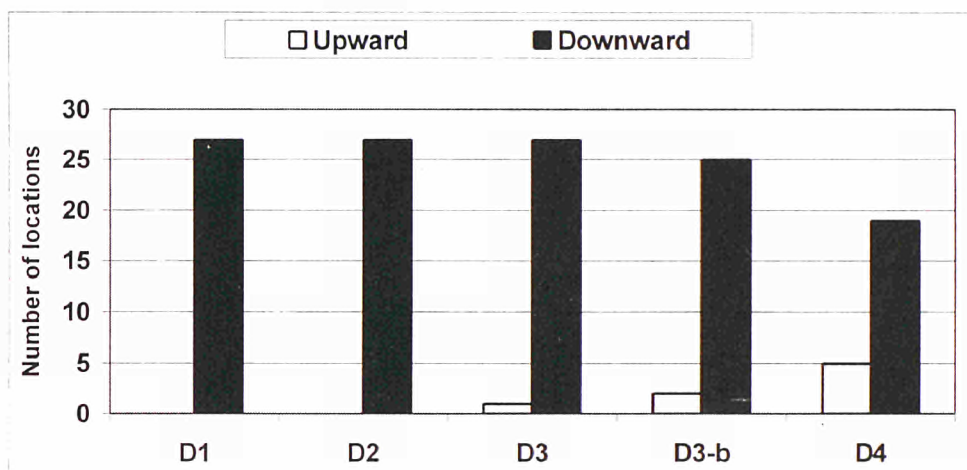


Gas prices for EU households on 1 July 1999: downward trend

A study of the variations in deflated (all taxes included) gas prices for households expressed in national currency from 1 January to 1 July 1999 reveals an average drop which affected all categories of standard consumers¹:

The main drops were recorded in Spain for all standard consumers (-6%) and in France for all standard consumers in Paris (-5.6%) and Strasbourg (between -5.1% and -5.8%). Other significant drops were recorded in Finland for D3 (-5.9%) and D4 (-4.4%), Luxembourg for D3 to D4 (between -5.4% and -5.7%) as well as in Rotterdam for D2 to D4 (between -4.5% and -5.5%).

The biggest rises were recorded in Germany for D3 to D4 (between +4.8% and +6.4%) in Düsseldorf and for D4 (+3.7%) in Munich.

This publication includes all prices collected by EUROSTAT corresponding to 1 July 1999 expressed in national currencies, purchasing power standards (PPS) and euros¹.
