

#### EXPLANATORY MEMORANDUM

The Commission adopted and transmitted to the Council on 18 February 1994 two proposals for rules for the participation of undertakings, research centres and universities in the RTD programmes, one proposal covering the EC programmes and the other covering the EAEC programmes, and a proposal for the rules for the dissemination of research results from the specific EC programmes. These proposals were included in a single document COM(94)12.

At the Plenary session on 5 May, the European Parliament has given its opinion on the proposals in accordance with paragraph 2 of Article 130 O and Article 189 C of the EC Treaty, and Article 7 of the EAEC Treaty.

The European Parliament has approved the proposals of the Commission subject to three similar amendments for the participation rules for the EC and EAEC programmes, and two amendments for the dissemination rules.

The Commission has accepted the substance of these amendments. In accordance with the position taken by it before the European Parliament, and paragraph 2 of Articles 189 A of the EC Treaty and 119 of the EAEC Treaty, the Commission submits the following modified proposals relating to the participation and dissemination rules which were the subject of the opinion of the European Parliament on 5 May 1994.

The proposal for a Council Decision concerning the Rules for the participation of undertakings, research centres and universities in the specific programmes of research, technological development and demonstration of the European Community (COM(94)12 final, 94/0012(SYN))<sup>(1)</sup> is amended as follows:

# Article 3.1 first subparagraph

As a general rule, proposals for RTD activities shall be selected on the basis of calls for proposals published in the Official Journal of the European Communities. In the call for proposals, the procedure used shall keep the administrative costs within strict limits.

### Article 6.1 second subparagraph

This participation shall consist of the timely reimbursement of a proportion of the costs of the activity. The reimbursement shall be determined by the Commission having regard in particular, as appropriate, to negotiated costs, scales or tariffs established in advance, amounts linked to measurable research results, or global fixed amounts for small-scale projects.

#### Article 9

This Decision is addressed to the Member States. It shall apply to RTD actions adopted by the Council after the multiannual framework programme 1994-1998 enters into force and shall apply until it is replaced by another Decision of the Council based on Article 130J of the Treaty. The annual report that the Commission submits to the European Parliament and to the Council in accordance with this Framework Programme shall contain information on the implementation of this Decision.

Before the end of this Framework Programme, the Commission shall review this Decision.

The annual report that the Commission submits to the European Parliament and to the Council in accordance with this Framework Programme shall contain information on the implementation of this Decision.

Before the end of this Framework Programme, the Commission shall review this Decision.
