NEWS

STOA has been elected to the Chairmanship of the European Parliamentary Technology Assessment (EPTA) network, and 3 new countries have joined EPTA: Finland, Greece and Italy. The Chairman of the STOA Panel, Mr Alain POMPIDOU (F, UPE) was elected Chairman of the EPTA Council for 1998 at the annual meeting of the Council in Copenhagen on 26 September 1997. Mr David BOWE, Vice-Chairman, also represented the STOA Panel. STOA succeeds the Danish Techology Council, which hosted this year's conference and Council meeting on 25-26 September. The topic of the Conference was 'The impact of parliamentary technology assessment'. Mr Dick HOLDSWORTH, Head of the STOA Unit, was among those who made presentations.
A financial report, being delivered to the STOA Panel at its meeting on 23 October in Strasbourg, will show that STOA has beaten last year's milestones in the launching of projects and commitment of appropriations.
Mr Stéphane BUFFETAUT (F, I-EDN) is the new representative on the STOA Panel for the Committee on Legal Affairs and Citizens' Rights, taking over from Mr FABRE-AUBRESPY.
Mr MITSOS, Director at DGXII.G of the European Commission is giving a presentation on Targeted Socio-Economic Research (TSER) at the STOA Panel meeting of 23 October. An information dossier is available.
It is planned to organise a one-day seminar on 'Quality in parliamentary technology assessment (TA): The European dimension', involving researchers and experts from all EU countries, in Marseille on 12 December. Prof. Jean-Louis ARMAND, STOA's Chief Adviser on Quality Control, is the leader of the project.
A visit is planned to the Electronic Data Management system of the city of Köln on 7 November 1997 (provisional date). Further information from the STOA Unit.


