## **STOA WORKPLAN 2000**

Despite late adoption of the STOA Workplan this year, due to circumstances beyond our control, hard work by all concerned (including work on weekends and evenings) has resulted in all our year 2000 projects being well and truly launched, as well as the taking on board of two more. The first proposed by Mr. Speroni, is on the need for coordinated civil and military air traffic control in the EU (AFET). The second is a study on some of the more controversial aspects of the effect of electromagnetic radiation on the environment and on human health and has been proposed by the ITRE Committee.

Thanks are due to the heroic STOA Team who, despite all the obstacles put in their way, have succeeded in getting the Workplan launched.

## **EPTA**

EPTA is the association of Parliamentary technology assessment in the EU and exists in order to exchange information, best practice and ideas among its member organisations which range from the German TAB to the UK's POST. The EPTA annual meeting will take place in Berlin at the new Reichstag on November 9<sup>th</sup> and 10<sup>th</sup>. STOA will of course be represented and will give an account of the issues surrounding STOA's work on "Silicone gel breast implants" and "Health Effects of Electromagnetic Waves."

## **SCIENTIFIC ADVISORY GROUP**

This is the new name given to the former "Quality Control Advisors", who are experts from EPTA members who help STOA assess the value of its studies and offer a critique of our methods. A meeting was held to discuss the modus-operandii of the group in Brussels on September 19<sup>th</sup> and further visits by the Group are planned, in principle for the November session.

## **COMINGS AND GOINGS (personnel)**

Jackie Weiwers, for long the lynch-pin of the STOA Secretariat in Luxembourg, -secretary, assistant, troubleshooter, "mother" to numerous STOA scholars and shoulder-to-cry-on for frustrated administrators, has had to leave us, owing to her family's moving to Brussels.

Jackie had become an institution in her own right and her incredible capacity for hard work, stoicism in the face of some of the planet's most intractable bureaucracy and invariable good humour will be sorely missed by all of us.

To cap it all, our sheet-anchor in Brussels, **Karin Sercu**, who for years has organised meetings, liaised with our contractors, organized the translation and publication on the "net" of STOA studies, troubleshooted, cajoled, persuaded and acted as the collective conscience, random access memory and central processing unit of STOA is also going to leave us for hopefully greener pastures in the ITRE secretariat. She will not be far away from STOA's activities and will be able to help with STOA/ITRE liaison (we hope). STOA wishes her well after 7 years with us. A replacement for Karin will be hard to find.

**Paul Engstfeld** is the new Head of Division responsible for STOA and has recently joined DGIV from the administration. However, he is an old Environment Committee hand with a wealth of experience and we are looking forward to working with him.

## **PRESENTATION OF STOA STUDIES**

### **Presentation of STOA projects at Committee meetings**

The 99/JURI/01 project on 'Digital technology evolution and its impact on the EU entertainment and media sectors' by Mr MARTINOLI of iCons, Italy, was successfully presented at the meeting of the Committee on Legal Affairs and the Internal Market on 12 September in Brussels.

A joint presentation of the 99/14/01 projects on 'Prison technologies' and 'Crowd control technologies' was made on 29 August, in Brussels before the Committee on Citizens' Freedoms and Rights, Justice and Home Affairs. This presentation was also much appreciated by the Committee.

These presentations are in line with STOA's policy of presenting major studies of wide interest before the Committee(s) requesting it, together with other interested Committees wherever possible. Smaller studies and those of more specific interest continue to be presented at the regular STOA Panel Meetings on Thursday afternoons in Strasbourg.

## STOA PANEL MEETINGS

The decision by Parliament to curtail the part sessions in Strasbourg in 2001 by finishing the part session on Thursday evening may have implications for the STOA Panel Meeting which has always been held on Thursday afternoons. It seems as though, on the one hand, more Members could remain on Thursday afternoon, but on the other that they may be taken up with other business. The matter will be discussed by the STOA Bureau.

## FUTURE PRESENTATIONS

Given the remarkable developments in many EU Member States concerning high fuel prices, the time may soon be ripe to organize a presentation to STOA of an interesting development in local transport. A French Formula One engine builder has developed a version of the internal combustion engine which is capable of running on compressed-air. It is essentially an electric car with a compressed-air battery and has a range of 200km on a tank full of compressed air. This is recharged overnight using a compressor operated on domestic electricity, using 20 kWh at a cost of around 2 €, i.e. a day's local driving for about 80BEF! Statistics show that the vast majority of car journeys are short.

The car is being developed near Nice in the South of France as an urban taxi and delivery van and produces exhaust comprising pure clean, cool air. The author has lain down behind a stationary car breathing in the exhaust gases!)

STOA hopes to be able to arrange a presentation of this vehicle to the STOA Panel next Spring.

## RAMON Y CAJAL (STOA) SCHOLARS

After much lobbying, Parliament's administration saw fit some time ago to extend the length of STOA scholarships to 4 months from 3. It is an improvement, but not much of one. Since the average project should last 6 months, we have a situation in which it is impossible for a scholar to follow a project from beginning to end, which is a disadvantage. Four months is still hardly time to become familiar with the arcane ways of the EU and it is doubtful whether either STOA or the scholars get as much out of the experience as we could.

In addition, STOA is becoming worried about the decline in candidates for STOA scholarships.

There is a particular lack of candidates from the northern European countries, including Denmark, Sweden and Finland, Ireland, England and Scotland, France, Belgium, Netherlands and Germany.
