independent living

Establishment of the European Committee on Sports for People with Disabilities

In response to growing demand from the various national sports organisations for disabled people and on the invitation of the European Commission, representatives appointed by the national olympic committees met on several occasions over the last two years to set up a European body whose purpose would be to provide advice and promote sports for disabled people. A European Committee on Sports for People with Disabilities was eventually established on 19 November 1993, on the initiative of the European Commission ("Integration of Disabled People" Unit of DG V and "Sports" Unit of DG X).

The committee will bring together two representatives of each national committee on sports for disabled people twice a year, and act as adviser to the Commission. Its tasks include delivering an opinion on applications for grants for sporting activities submitted to the Commission and promoting any initiative in the field of sports for disabled people. The Committee on Sports has elected Dr Bob PRICE, Chairman of the British Sports Association for the Disabled and Director of the British Paralympics Association, as its chairman and Mr K. V. NIELSEN, Chairman of the Danish Sports Organisation for the Disabled, as vice-chairman.

The Commission hopes that, within the framework of the HELIOS programme, the national committees on sports for people with disabilities will be able to develop cooperation with NGOs and national councils of organisations for disabled people. The Commission financed 15 sporting events for disabled people in 1993 and will provide a further 251,661 ecus for 25 projects selected by the Committee on Sports in 1994.

Establishment of the "Independent Living, Tourism for All" group

At the Commission's invitation, the "Independent Living, Tourism for All" group held its first meeting on 8 March 1994. The group comprises 36 government-appointed representatives of associations of physically disabled people, associations of people with learning difficulties, and professional bodies (travel agencies, etc.) –three from each Member State. The NGO which coordinates tourist activities within the HELIOS Disability Forum, Mobility International, attends meetings of the group as an observer.

"Independent Living, Tourism for All" is the product of a joint initiative of two of the European Commission's directorate-generals: DG V (Employment, Industrial Relations and Social Affairs, "Integration of Disabled People" Unit) and DG XXIII (Enterprise Policy, Distributive Trades, Tourism and Cooperatives, "Tourism" Unit). The meeting on 8 March was an opportunity to take stock of the present situation in the Member States regarding tourism for disabled people and sketch the prospects for a number of future initiatives.

CD-ROM 6

The sixth version of CD-ROM HANDYNET became available in early March. 300 copies were distributed in the Member States, mainly among the 170 information centres. Following its sixth update, the HANDYNET database now contains nearly 48,000 items on technical aids and the organisations which manufacture and distribute them, along with 2,144 illustrations of 1,700 products.

Evaluations

The HANDYNET network has continued to hold assessment sessions in the various Member States.

France In Paris on 31 January, HANDYNET France presented the conclusions of a national evaluation exercise involving 225 representatives of technical aid manufacturers and distributors and rehabilitation and medico-social professionals. Five regional assessment sessions were held in late 1993.

The assessors gave HANDYNET their seal of approval, stating that it meets their information needs concerning products and manufacturers; they advocated wide distribution of the CD-ROM, while believing that a specialist should always be available to assist with accessing the system.

Germany And on 17 and 18 May, Cologne (D) will play host to the European HANDYNET evaluation session, organised jointly by the Commission and the Institut der Deutschen Wirtschaft in Cologne. The meeting will focus on the content of the database, access to information, the role of the HANDYNET study groups and the way the network is organised. The purpose is to analyse information needs, particularly regarding employment and accessibility, with a view to a preliminary assessment of prospects for the development of other modules in the HANDYNET system (the first being devoted to technical aids).

The draft HANDYNET evaluation report, which the Commission must submit to the Council and European Parliament in July 1994, was examined at the meeting of the HANDYNET technical coordination group on 13 April, and will be discussed again at the European evaluation session.

A group of six experts met in 1993 and 1994, under the auspices of the European Blind Union and with support from the Commission under the HELIOS programme, to put forward proposals and recommendations on the form a future single or common European currency should take (coins, bank notes and electronic transactions in ecus) to accommodate the needs of blind and partially sighted people. The European Monetary Institute welcomed the proposals, which will be taken into account in the development of the European currency.

The Green Paper on European Social Policy was discussed at the meeting of the Forum on 19 April. The members of the Forum had submitted comments and suggestions, both severally and jointly, to Commissioner Flynn. In particular, the Forum called for the HELIOS programme to be stepped up.

TIDE The TIDE initiative (Technology Initiative for Disabled and Elderly people, DG XIII) is assisted by an Expert Committee (one member from each Member State). Further to the conclusions of the joint DG V / DG XIII seminar on new technology held on 17 and 18 January (see Flash No. 3, p. 3), the committee decided to invite a representative of the European Disability Forum to take part in its work. Mr Boulinier, Vice-Chairman of the Forum, will be taking up the invitation.

Employment On 16 February, the Commission adopted a number of social policy initiatives for 1994-1999.

Three involve human resources:

- The NOW II initiative, which aims to reduce joblessness among women and improve the working conditions of those of them in employment. Budget allocation: 370 million ecus.
- The HORIZON initiative, intended to promote measures to improve access to the labour market for excluded and disadvantaged sections of the population. The main target groups are disabled and disadvantaged people (young people at risk, immigrants, refugees, isolated people, one-parent families, travellers, prisoners and former prisoners, the homeless, etc.).

A budget allocation of 730 million ecus is proposed for HORIZON for the 1994-1999 period.

The new initiative YOUTHSTART, which is designed to prevent unemployment among young people under the age of 20. Budget for 1994-1999: 300 million ecus.

Another initiative, ADAPT, deals with employment and the adaptation of the workforce to industrial change. It has a budget allocation of 1.4 billion ecus.

Social charter The third European Commission report on the application of the Community Charter of the Fundamental Social Rights of Workers was published in December 1993. The first part of the report deals with the application of the Charter at Community level, the second with its application in the individual Member States. Each section contains a few paragraphs on disabled people. The report is nearly 300 pages long, and is published under the reference COM(93) 668 (catalogue No. CB-CO-93-727) by the Office for Official Publications of the European Communities in Luxembourg (tel.: +352-49.92.81).

Education and youth The Commission has submitted draft decisions to the Council and the European Parliament on three new Community programmes for education, training and youth exchanges.

The LEONARDO programme (proposed on 21.12.93) is intended to stimulate vocational training and replace, from 1995, the existing COMETT, PETRA, FORCE and EUROTECNET programmes. Publication reference: COM(93) 686 final-SYN-94

The SOCRATES programme put forward on 4 January 1994 is designed to promote the European dimension of education, from primary school to university. Over the 1995-1999 period, SOCRATES will take over from the existing ERASMUS and LINGUA programmes, whose activities it will extend to primary and secondary education.
