European Industrial Information Transfer Agencies must get together

A second meeting of representatives of European industrial information transfer (IIT) agencies was held by the Commission in Luxembourg on 21 April 1983 (a report on the first meeting held on 20 September 1982 was given in Newsletter N. 17). This time all Member States were respresented, as well as the IRI international regional cooperation institute (Institut für regional-politische Zusammenarbeit in innergemeinschaftlichen Grenzräumen/Institut pour la Coopération Régionale dans les Régions Frontalières Intracommunautaires) and the Parliamentary Assembly of the Council of Europe. An observer from Sweden was also present.

Stock was taken of reactions received from different sources to the results of the first meeting. A clear convergence of views was noted towards the need in Europe, mooted at the first meeting, to maintain and if necessary create agencies providing a comprehensive forward-looking information service to small and medium-sized firms, notably with the aim of helping them to innovate and diversify.

An essential qualification for the effectiveness of these agencies is a thorough knowledge of the firms they have to serve. This explains why their activities are usually best limited to a particular region.

The desirability of organising permanent contacts between IIT agencies was also confirmed. Not only could they thus exchange methodological experience, as well as actual technological and economic information for the benefit of their clients, but they could do much towards promoting collaboration between enterprises belonging to different regions. The ideal partners of a particular firm, in terms of research development, marketing, etc. may indeed often be found outside its home country.

It was decided to work out immediately a blueprint for a European association or network of IIT agencies, ready for implementation within the framework of the plan for a transnational infrastructure for innovation which the Commission has proposed to the Council of Ministers.

Call for proposals

The Commission would welcome proposals for projects for the creation of new computerized information services for public access or improvement of existing services. It is prepared to give financial assistance to a limited number of projects.

The Commission would give priority to proposals in the fields of biomedicine and health care, including biotechnology.

Financial support

Selected projects can benefit from a subsidy covering up to 25% of the development costs directly related to the projects during a maximum period of 24 months preceding commercialization, subject to a ceiling of 200 000 ECU.

Euroarticle Project

The Euroarticle Project is the result of a cooperation between six of the major scientific periodicals in Europe (European Journals Group for Science and Technology): Endeavour (United Kingdom), Umschau in Wisschenschaft und Technik (Federal Republic of Germany), La Recherche (France), Annuario della Scienza e della Tecnica (Italy), Natuur en Techniek (The Netherlands) and Technology Ireland (Ireland). These periodicals have agreed to publish a series of articles of European interest, the translation into different languages being taken care of by the Commission of the European Communities. The articles are thus given a much wider audience across European language barriers.

It should be remarked that in 1982, the aggregate number of main articles published by these journals was 171 of which 45 were Euroarticles. The Euroarticle input therefore represents 26% of the total.
