# COUNCIL DIRECTIVE

on the undesirable substances and products in animal nutrition

(consolidated version)

(presented by the Commission pursuant to Article 189 a (2) of the EC-Treaty)

#### Explanatory memorandum

- 1. On 6 December 1995, the Commission presented a proposal for a Council Directive codifying Council Directive 74/63/EEC of 17 December 1973 on the undesirable substances in animal nutrition (1).
- 2. In view of the outcome of the work already carried out in the Council on the proposal referred to at point 1., the Commission has decided to present in accordance with Article 189a (2) of the EC Treaty an amended proposal for codification of the Directive in question, as set out in the attached text (Annex I).

This amended proposal also takes account of amendments purely of form or wording by the Consultative Working Party of Legal Services set up under the Interinstitutional Agreement of 20 December 1994 on an accelerated working method for official consolidation of legislative texts, where these are considered justified (2).

3. To facilitate reading and examination, the <u>full</u> text of the amended proposal for codification is also attached (Annex II).

#### AMENDED PROPOSAL FOR A COUNCIL DIRECTIVE

#### on the undesirable substances in animal nutrition

#### consolidated version

The proposal for a Council Directive – consolidated version COM(95)598 final of 6. 12. 1995 – 95/0299 (CNS) is amended as follows:

- 1. Footnote 3 relating to recital 1 shall be replaced by the following text:
- '3. OJ No L 38, 11. 2. 1974, p. 31. Directive as last amended by Commission Directive 97/8/EC (OJ No L 48, 19. 2. 1997, p. 22).'
- 2. In all cases, the term 'straight feedingstuffs' shall be replaced by the term 'feed materials' and the reference '96/25/EC Art 14 (2) (a)' shall be inserted into the right-hand margin.
- 3. In all cases, the term 'raw material' shall be replaced by the term 'feed materials' and the reference '96/25/EC Art 14. (2) (e)' shall be inserted into the right-hand margin.
- 4. Article 2 (b) shall be replaced by the following text:
- '(b) "feed materials": various products of vegetable or animal origin, in their natural state, fresh or preserved, and products derived from the industrial processing thereof, and organic or inorganic substances, whether or not containing additives, which are intended for use in oral animal feeding, either directly as such or after processing, in the preparation of compound feedingstuffs or as carriers of premixtures;'

- 5. Article 2 (e) shall be replaced by the following text:
- '(e) "compound feedingstuffs": mixtures of feed materials, whether or not containing additives, which are intended for oral animal feeding as complete or complementary feedingstuffs;'

- 6. Article 2 (f) shall be deleted.
- 7. Article 5 (2) (a) shall be replaced by the following text:
- '(a) it is intended for use by establishments which meet the conditions of Council Directive 95/69/EC (1).

#### THE COUNCIL OF THE EUROPEAN UNION.

Having regard to the Treaty establishing the European Community, and in particular Article 43 thereof;

Having regard to the proposal from the Commission;

Having regard to the Opinion of the European Parliament (1);

Having regard to the Opinion of the Economic and Social Committee (2);

- (1) Whereas Council Directive 74/63/EEC of 17 December 1973 on the undesirable substances in animal nutrition (3) has been frequently and substantially amended; whereas for reasons of clarity and rationality the said Directive should be consolidated;
- (2) Whereas livestock production occupies a very important place in the agriculture of the Community; whereas satisfactory results depend to a large extent on the use of appropriate good-quality feedingstuffs;
- (3) Whereas the existence of rules concerning feedingstuffs is essential to an increase in agricultural productivity;
- (4) Whereas feedingstuffs often contain undesirable substances or products which can endanger animal health or, because of their presence in livestock products, human health;
- (5) Whereas it is impossible to exclude totally the presence of the substances and products in question; whereas it is important that their content in feedingstuffs should be reduced in order to prevent undesirable and harmful effects; whereas it is at present impossible to fix this content below the levels detectable by methods of analysis to be defined for the Community;

- (6) Whereas undesirable substances and products may be present in feedingstuffs only in accordance with the conditions laid down in this Directive and may not be used in any other way for the purposes of animal feeding; whereas this Directive should therefore apply without prejudice to other Community provisions on feedingstuffs, and particularly the rules applicable to compound feedingstuffs;
- (7) Whereas Member States should, however, retain the power to allow, under certain conditions, feedingstuffs having levels of undesirable substances and products higher than those provided for in Annexes I and II;
- (8) Whereas this Directive must apply to feed materials and feedingstuffs from the date of their introduction into the Community; whereas it should therefore be stipulated that the maximum levels of undesirable substances or products set apply in general from the date on which the feed materials and feedingstuffs are put into circulation, including all stages of marketing, and in particular from the date of their importation;
- (9) Whereas it is advisable to establish the principle that raw materials used in animal nutrition must be sound, genuine and of merchantable quality; whereas, therefore, it is necessary to prohibit the use or putting into circulation of <u>feed materials</u> which, because they contain too high a level of undesirable substances or products, result in the maximum levels for compound feedingstuffs laid down in Annex I being exceeded;
- (10) Whereas it is proper to limit the presence of certain undesirable substances or products in complementary feedingstuffs by fixing appropriate maximum levels;
